## Data Policy and Legislation

<u>European Data strategy</u> – Common European Data Spaces; Feb 2020

Open Data Directive: transposition D/L: 2021; implementing act on High-Value Datasets, HVD): in force since Feb 2023; applies from June 2024

Data governance act (in force since June 2022; applies from Sep 2023)

Data act (in force Jan 2024; applies from September 2025)

Al act (in force Aug 2024; staged application)

## Compliance projects over time (>200MEUR, 34 projects)

#### Horizon 2020 Call 2016 (8 + 1 MEUR, 3 RIA, 1 CSA)

ICT-18-2016: Privacy-preserving Big Data Technologies *Methodologies for privacy preservation: multi-party computing, homomorphic encryption, anonymization/pseudonymization* 

#### Horizon 2020 Call 2018/2019 (10 + 48 MEUR, 4 RIA, 9 IA)

ICT-13-2018-2019: Supporting the emergence of data markets and the data economy *Personal data protection, consent (more practical GDPR compliance), data sharing & trading models and platforms as sandboxes* 

#### Horizon Europe Call 2021 (52 MEUR, 5 RIA)

HORIZON-CL4-2021-DATA-01-01: compliance, Privacy preserving technologies *Special attention to green&responsible data operations, privacy preservation in particular use contexts (mobility, e-commerce, finance, healthcare, public administration, industry...)* 



### Compliance projects over time (>200MEUR, 34 projects) cont'd

#### Digital Europe Call 2022 (20/9 MEUR, 4 Simple Grants)

DIGITAL-2022-CLOUD-AI-02-OPEN-AI - Public Sector Open Data for AI Leveraging public sector data of high value, supporting the Open Data Directive and the implementing act on HVDs

#### Horizon Europe Call 2022 (52 MEUR, 4 IA)

HORIZON-CL4-2022-DATA-01-04 Data trading, monetizing, exchange, interoperability Secure and trustworthy exchange of proprietary data, marketplaces, automated contracting

#### Horizon Europe Call 2024 (38 MEUR, 4 IA)

HORIZON-CL4-2024-DATA-01-01: Al-driven data operations and compliance technologies Broader approach to compliance, first link to AI (data for AI, bias measures for datasets, Data Act article 10)

### Remaining challenges and new angles to compliance

Take compliance in the broad sense: legal/ethical compliance with any applicable rules & norms (including standards), not only Data/AI legislation, but sectoral legislation as well (agriculture, climate, financial reporting...)

Cut red tape, bureaucracy and reporting burden for companies, farmers, citizens... using data & AI; build in **automated reporting** in administrative systems and services.

Create systems and methods that (automatically) adapt to continuously changing legislation & rules & contexts (eLegislation)

Use of synthetic data where the use of real data is not possible?
